

Instructions for Logging on to ERS for Annual Enrollment

1. Go to <http://www.ers.state.tx.us/>
2. Click on the brown "My Account Login" button in the upper right corner.
3. Click on the brown "Proceed to Login" button on the left of the page just below My Account Login.
4. If you have an account you will enter your username / password, then click the yellow "Sign In" button.
5. If you do not have an account click on the yellow "Register" button in order to create a user name and password.

Benefits Enrollment

Your coverage can only be changed during Annual Enrollment or if you have a qualifying life event during the year.

To begin your enrollment, click the yellow **Select** button.

Once you click Select, it will take a few seconds for your benefits enrollment information to load.

- Read the new rules regarding TexFlex and click the "OK" button.

*** Important TexFlex Enrollment Message ***

You will now be able to carry over up to \$500.00 of your Plan Year 2015 TexFlex health care account funds (contribution amount from 9/01/2014 - 8/31/2015) into the next plan year. The carry over will replace the grace period for the TexFlex health care account. The grace period for the TexFlex day care account will not be affected because the carry over only applies to the TexFlex health care account.

There will be an "administrative fee holiday" so you won't have to pay \$12.00 per account this plan year. There is an annual TexFlex debit card fee of \$15, should you elect to use the debit card.

- Click the yellow "Edit" button next to the benefits you would like to change. If you add yourself or a dependent on to the Medical Plan you must certify Tobacco Use. Click on the yellow "Edit" next to Tobacco User Certification to certify you and/or your dependent's tobacco use.

Annual Enrollment is an opportunity to change your coverage elections. This year, re-enrollment in TexFlex is automatic unless you make a change during Annual Enrollment.

You will be able to review each coverage cost on the Enrollment Summary.

Important: The 'New' selection shown in the Enrollment Summary below reflects the September 1st coverage or the coverage you will have after your waiting period and is your online confirmation of elections.

Submit Click **Submit** to store your Annual Enrollment elections.
