### ***TITLE***

Research Technician III

### ***JOB SUMMARY***

Performs skilled, technical support research work involving performance of assignments which may involve planning and directing certain phases of a research project. Work is performed under limited supervision with performance is based on the overall success of the project/phase assigned. The performance evaluation is conducted through the performance evaluation system and in accordance with the University Policies & Procedures.

### ***ORGANIZATIONAL RELATIONSHIPS***

*Reports to:* Department head

*Supervises:* Student Assistants and/or Research Technician I and Research Technician II.

### ***ESSENTIAL DUTIES - May include, but not limited to the following:***

- Conducts various tests or experiments requiring creativity, foresight, and judgment.
- Performs complex analysis and examinations.
- Assists Investigator with the planning and direction of specific phases of a research project.
- Computes quantities and extends projections.
- Makes and records observations and scientific measurements.
- Assembles and operates technical equipment.
- Designs and/ or modifies special apparatus and equipment.
- Prepares technical reports and summaries.

### ***ADDITIONAL DUTIES***

- Performs other duties as requested.

**EDUCATION**

Bachelor's degree with major coursework in the field of assignment.

**EXPERIENCE**

A minimum of one year related experience. Additional related experience may substitute for the required education on a year-for-year basis.

**REQUIREMENT**

Regular and reliable attendance at the University during regular scheduled days and work hours is an essential function of this position.

**KNOWLEDGE, SKILLS, AND ABILITIES - The following are essential:**

- Knowledge of scientific techniques and methods used in routine research.
- Knowledge of equipment and safety precautions related to work.
- Ability to follow directions and supervise.
- Ability to make accurate assays.

- Ability to organize work effectively, conceptualize and prioritize objectives and exercise independent judgment based on an understanding of organizational policies and activities.
- Ability to establish and maintain effective work relationships with students, faculty, staff, and the public.
- Ability to communicate effectively orally, by phone, in person, and in writing.
- Ability to represent the department and University in a friendly, courteous, and professional manner.
- Ability to use a personal computer and other office equipment, including university related software and email.
